

1. Call to Order: Chair Wolter called the meeting to order at 4:05 p.m. Present: Chair, Council Member Gus Wolter, Mayor MaryAnn Brigham, City Manager Paul Cayler and ACM/CDD David Kelley. Absent: None

**4. Approval of Minutes:** The minutes of August 24, 2016, were approved.

## 5. Current Items for Discussion:

- a. 2016 Inclusionary Zoning Ordinance (IZO) In Lieu Fee Update Mr. Kelley gave a brief background on the IZO, noting the last fee update was in 2008, and summarized the way in lieu fees are calculated. Mr. Kelley stated a presentation is being developed to bring before the City Council regarding the Nexus methodology of calculating fees for rental units. Discussion regarding affordable housing ensued. The subcommittee recommended the presentation to the City Council occur before bringing the fee resolution before the Planning Commission for their adoption.
- b. Begin discussion on allowable zoning for new cannabis industry Mayor Brigham gave a brief report of the County meeting she attended regarding cannabis cultivation and stated the City needs to start a discussion about what Cloverdale will allow and where. Discussion ensued regarding Cloverdale's zoning and cannabis cultivation, energy conservation, dispensaries, sensitive receptors, updating zoning provisions, and methods of issuing initial permits.

- a. Update on Thyme Square Master Plan Mr. Kelley delivered a brief update.
- **b.** Discussion of City Council assumption of Planning Commission items Mayor Wolter stated this item is a placeholder and at Mr. Kelley's discretion, he will call for a joint meeting with the Planning Commission and the City Council.
- c. Update on annexation of the All Coast and Renner properties Mr. Kelley stated considerable staff time and work is required to bring an annexation forward, as well as fees and developer deposits associated with that. Discussion of the City's formal annexation process will need to be conducted with them.
- d. Mayor Wolter related that he and Vice Mayor Palla have been talking about the empty storefront fee and stated the city of Willits is in the process of adopting an ordinance. He would like to see that as a standing future agenda item.

- **9. Good of the Order:** Mr. Cayler related that the North Bay Business Journal's conference, "The State of the Cities" will offer a table of ten for Cloverdale, October 19, 2016.
  - Mr. Cayler stated that next week staff is looking at bringing in a consultant to do code enforcement, which is goal #2 on the top 10 list, and will have a meet and greet with the right profile, which includes knowledge of code enforcement, working well with people, and good verbal skills, and will meet and greet with this candidate next week,..
