1. **Call to Order:** Chair Wolter called the meeting to order at 4:00 p.m. noting for the record that all subcommittee members were present.

**c.** Smoking control ordinance – Friday Night Live

Chief Cramer went over a Power Point presentation for upgrading the City's outdated smoking ordinance. The subcommittee recommended this be brought before the City Council.
