RESOLUTION NO. 97-2019

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE APPROVING A CONTRACT AWARD TO THE DUBLIN AUTOMOTIVE GROUP OF DUBLIN, CA FOR THE PURCHASE OF TWO (2) NEW 2019 GMC 2500 UTILITY MAINTENANCE VEHICLES IN AN AMOUNT NOT TO EXCEED SEVENTY NINE THOUSAND DOLLARS (\$79,000); AUTHORIZING THE PURCHASE OF ASSOCIATED NECESSARY EQUIPMENT IN AN AMOUNT NOT TO EXCEED THIRTY THOUSAND DOLLARS (\$30,000) FROM VARIOUS VENDORS; AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE SAID CONTRACT IN A FORM APPROVED BY THE CITY ATTORNEY

WHEREAS, the Cloverdale Public Works Department currently has twenty-three (23) vehicles in service; and

WHEREAS, of the twenty-three (23) vehicles, three (3) vehicles are scheduled for replacement this fiscal year due to excessive mileage and expensive repairs due to age of the vehicles and/or excessive mileage; and

WHEREAS, the purchase of two new vehicles will replace two (2) aging vehicles, upgrade the City's fleet of utility vehicles, and alleviate budgetary impacts due to high vehicle maintenance needs; and

WHEREAS, the Public Works Department secured quotations from three local vendors; and

WHEREAS, the Dublin Automotive Group of Dublin, CA was the lowest responsible bidder and had the lowest quote at SEVENTY-EIGHT THOUSAND SEVEN HUNDRED THIRTY-FIVE DOLLARS AND 64/100 (\$78,735.64); and

WHEREAS, utility vehicles are manufactured without the needed work and emergency lights; and

WHEREAS, additional funds will be needed to outfit the vehicles with work and emergency lights, and tool and equipment of a cost not to exceed THIRTY THOUSAND DOLLARS AND 00/100 (\$30,000.00); and

WHEREAS, these vehicles are included in the FY 2019/20 budget and will be paid \$49,500 by the parks department (100.40.404.44110.000) and \$59,500 by the water enterprise (600.40.800.4411.000)


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Cloverdale hereby: (1) approves a contract award to Dublin Automotive Group of Dublin, CA for the purchase of two (2) utility vehicles for an amount not to exceed \$79,000; (2) authorizes the purchase of associated necessary equipment in an amount not to exceed \$30,000 from various vendors; and (3) authorizes the City Manager or designee to execute said agreement on behalf of the City in a form approved by the City Attorney.
