**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE APPROVING
A LETTER OF AGREEMENT FOR PARTICIPATION IN SONOMA COUNTY TRANSIT'S
"FARE-FREE" PROGRAM FOR CLOVERDALE LOCAL ROUTE 68 – THE
"CLOVERDALE SHUTTLE" FOR THE PERIOD OF JULY 29, 2019 TO JUNE 30, 2020;
AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT**

WHEREAS, In June 2018, Sonoma County Transit (SCT) introduced its "Fare-Free" program on Sebastopol local Route 24, following a City led community outreach program to identify new ideas for increasing interest in local transit services, boosting Route 24's usage and broadening its user base; and

WHEREAS, the intent of the "Fare-Free" program has been to encourage interest and promote use of local transit services, expand the user demographic on local routes and to provide an easy to use "Hop-On, Hop-Off" service for all passengers; and

WHEREAS, Bryan Albee, Transit Systems Manager of Sonoma County Transit, approached City staff in October 2018 regarding an opportunity to bring the Fare-Free Program to Route 68 and the City of Cloverdale; and

WHEREAS, the City of Cloverdale receives public transit services provided by Sonoma County Transit that include local Route 68 and intercity Routes 56 and 60; and

WHEREAS, the City of Cloverdale desires to promote the use of local Route 68, also known as the "Cloverdale Shuttle," as a convenient local transportation alternative for travel within the CITY's incorporated area by subsidizing fares for all riders.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Cloverdale hereby: (1) approves a Letter of Agreement for Participation in Sonoma County Transit's "Fare-Free" Program for Cloverdale Local Route 68 – The "Cloverdale Shuttle" for the period of July 29, 2019 to June 30, 2020; and (2) authorizes the City Manager to execute the agreement.

The foregoing Resolution No. 54-2019 was duly introduced and adopted by the City Council of the City of Cloverdale at its regular meeting held on the 24th day of July 2019, by the following roll call vote:


