

**CITY OF CLOVERDALE CITY COUNCIL
RESOLUTION NO. 112-2019**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE APPROVING A PROFESSIONAL SERVICES AGREEMENT WITH PRECISION WIRELESS SERVICE FOR THE PURCHASE AND INSTALLATION OF HI-LO EMERGENCY ALERT SIRENS AND EQUIPMENT FOR POLICE VEHICLES IN AN AMOUNT NOT TO EXCEED \$6,074.81 PLUS A 10% CONTINGENCY FOR POTENTIAL OVERRUNS AND AUTHORIZING THE CITY MANAGER TO EXECUTE SAID AGREEMENT WITH CITY ATTORNEY APPROVAL

WHEREAS, as part of the emergency preparedness plan for the City, the Police Department seeks to install Hi-Lo emergency alert sirens in each police vehicle; and

WHEREAS, only one new vehicle in the fleet is equipped with a Hi-Lo siren; and

WHEREAS, several of the vehicles are already equipped with proper consoles that only require reprogramming of the unit; and

WHEREAS, the remaining vehicles require installation of hardwiring, siren and toggle switch to be fully functional; and

WHEREAS, a critical component in the early stages of emergency preparedness is alerting residents of looming disasters that pose immediate threats to life and property; and

WHEREAS, Hi-Lo sirens, installed in patrol vehicles, are designed to provide rapid notification throughout the community using an audible siren at the onset of emergencies; and

WHEREAS, Hi-Lo sirens provide a unique audible sound that differs from standard sirens alerting citizens to evacuate the area immediately; and


WHEREAS, Hi-Lo sirens provide early warnings to residents who would otherwise not receive notifications through social media platforms and SMS messaging.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Cloverdale hereby approves a Professional Services Agreement with Precision Wireless Service and authorizes the City Manager to execute said agreement on behalf of the City with City Attorney Approval.
