RESOLUTION NO. 114-2019

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE AUTHORIZING THE CITY MANAGER TO APPROVE PAYMENT OF INVOICES ON BEHALF OF THE CLOVERDALE MUNICIPAL AIRPORT FOR THE PURCHASE OF AVIATION FUEL FROM WORLD FUEL SERVICES UP TO THE BUDGETED AMOUNT OF \$65,000 INCLUDING AN EXISTING INVOICE IN THE AMOUNT OF \$30,660.23**

**WHEREAS**, the Cloverdale Municipal Airport historically purchases aviation gasoline for resale at the Cloverdale Municipal Airport for airport and aviation related uses; and

**WHEREAS**, the adopted FY 2019-20 budget identifies funding for the purchase of aviation gasoline is budgeted in in the amount of \$65,000; and

**WHEREAS**, City staff typically orders fuel twice a year to ensure there is an adequate supply of fuel to purchase by private aviation uses of the Cloverdale Municipal Airport; and

**WHEREAS**, the City previously executed a contract with World Fuel services for the purchase of aviation gas;

**WHEREAS**, the City received the first of two annual invoices from World Fuel Services the first of which exceeded the City Manager's signing authority of \$25,000; and

**WHEREAS**, Authorization from the City Council is required for purchases that exceed the City Manager's purchase authority.


**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Cloverdale hereby authorizes the City Manager to approve payment of invoices on behalf of the City for the purchase of aviation fuel from World Fuel Services on behalf of the Cloverdale Municipal Airport from World Fuel Services up to the budgeted amount of \$65,000 including an existing invoice in the amount of \$30,065.

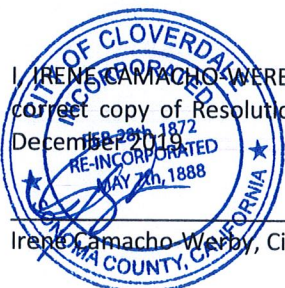
