RESOLUTION NO. 023-2020

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE APPROVING AMENDMENT NO.1 TO THE PROFESSIONAL SERVICES AGREEMENT WITH KEYSER MARSTON ASSOCIATES TO PROVIDE ADDITIONAL ASSISTANCE PURSUANT TO SAFETY CODE 33433 FOR THE CHERRY CREEK AFFORDABLE HOUSING PROJECT AT 520 S. CLOVERDALE BLVD. IN AN AMOUNT NOT TO EXCEED \$10,000; AND AUTHORIZING THE CITY MANAGER TO EXECUTE SAID AMENDMENT

WHEREAS, on June 10, 2020, the City of Cloverdale and Keyser Marston Associates entered into a Professional Services Agreement to provide financial analysis for the Cherry Creek Affordable Housing Project at 520 S. Cloverdale Blvd.; and

WHEREAS, additional work related to the preparation of a Summary Report pursuant to California Health and Safety Code 33433 is required to complete the project and

WHEREAS, City Staff requested Keyser Marston Associates to provide a scope of work for the additional work is required to complete the Summary Report required for the project; and

WHEREAS, Consultant proposes to increase the total "Not to Exceed Amount" by \$10,000 to perform the tasks outlined in the attached Scope of Work; and


WHEREAS, City staff is requesting that the City Council approve an amendment to the Professional Services Agreement with Keyser Marston Associates to revise the Scope of Work and payment terms and not to exceed amount;

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Cloverdale hereby approves Amendment No. 1 to the Professional Services Agreement with Keyser Marston Associates to revise the Scope of Work and increase the not to exceed amount by \$10,000 and authorizes the City Manager to execute said amendment on behalf of the City.


