RESOLUTION NO. 027-2020

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE APPROVING A PROFESSIONAL SERVICE AGREEMENT WITH MOE ENGINEERING, INC., FOR PROJECT MANAGEMENT SERVICES TO CONSTRUCT A NEW EQUIPMENT STORAGE BUILDING AT THE CORPORATION YARD IN A FORM APPROVED BY THE CITY ATTORNEY

WHEREAS, MOE Engineering, Inc. has presented a proposal to provide project management (PM) services to construct a new equipment storage building at the corporation yard; and

WHEREAS, MOE Engineering, Inc. is qualified to provide construction PM services; and

WHEREAS, MOE Engineering, Inc. provided a cost estimate for the not-to-exceed amount of \$71,060.00 to provide PM services for the Cloverdale Equipment Storage Building Project; and

WHEREAS, The City Council approved funding the Cloverdale Equipment Storage Building Project in the FY 2019/2020 budget under account 100-40-601-49130 in the amount of \$250,000.00; and

WHEREAS, the City Engineer requests authorization to extend the scope of the contracted services to include general engineering assistance (task orders) on an on-call basis until June 30, 2021; and


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Cloverdale does hereby authorize the City Manager to execute the agreement on behalf of the City with Moe Engineering in a form approved by the City Attorney and to issue a Task Order for the not-to-exceed amount of seventy-one thousand sixty dollars (\$71,060.00) for project management services for the Cloverdale Equipment Storage Building Project.

BE IT FURTHER RESOLVED that the City Council of the City of Cloverdale authorizes the City Manager to issue additional Task Orders for general engineering assistance on an on-call basis until June 30, 2021.


