RESOLUTION NO. 031-2020

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE AWARDING OF THE CLOVERDALE SAFE ROUTES TO SCHOOL PHASE II PROJECT TO TEAM GHILOTTI, INC IN THE AMOUNT OF \$322,195 AND NO CENTS, AUTHORIZE THE CITY MANAGER TO EXECUTE A CONTRACT WITH TEAM GHILOTTI, INC., APPROVE A BUDGET AMENDMENT AND APPROVE OVERALL BUDGET FOR THE PROJECT

WHEREAS, the City of Cloverdale has been awarded Federal Highway Administration (FHWA) funding in the amount of \$100,000.00 to install additional sidewalks and bicycle lanes on South Cloverdale Blvd. under the Safe Routes to School Program; and

WHEREAS, the City advertised for bid the Cloverdale Safe Routes to School Phase II project, City Staff reviewed all bids received, and identified TEAM Ghilotti, Inc. as the lowest responsive bidder with a bid of \$322,195.00; and

WHEREAS, TEAM Ghilotti, Inc. is qualified to perform the Cloverdale Safe Routes to School Phase II project; and

WHEREAS, the City of Cloverdale has identified funding from the Measure M Streets Sales Tax Fund account 212 and Reserve General Fund sufficient to fund the balance of the project.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Cloverdale hereby awards the Cloverdale Safe Routes to School Phase II project to TEAM Ghilotti, Inc., approves an overall budget of \$354,414,50 and authorizes the City Manager to execute a construction contract on behalf of the City.

BE IT FURTHER RESOLVED that the City Council approves a budget amendment reallocating Measure M Streets Sales Tax funds from account 212 to account 215 40-000-49130 and authorizes reallocation of Reserve General funds to account 215 40-000-49130 if needed to fully fund the project.
