RESOLUTION NO. 012-2021

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE AWARDING A CONTRACT FOR THE PURCHASE OF ONE JOHN DEERE 1570 TERRAIN CUT COMMERCIAL FRONT MOWER, TO BELKORP AG, LLC, OF STOCKTON CALIFORNIA, IN AN AMOUNT NOT TO EXCEED THIRTY-EIGHT THOUSAND DOLLARS (\$38,000.00) AND AUTHORIZING THE CITY MANAGER TO EXECUTE SAID PURCHASE CONTRACT

WHEREAS, the City of Cloverdale Parks and Recreation Department uses a commercial mower at City facilities; and

WHEREAS, the Cloverdale Parks and Recreation Department acquired this commercial mower in 1999 (approximately); and

WHEREAS, the existing commercial mower has needed continuous repairs and is mechanically impracticable to continue repairs; and

WHEREAS, purchasing a new, replacement commercial lawn mower will insure safe and reliable equipment; and

WHEREAS, the City of Cloverdale solicited three quotations from vendors for a John Deere 1570 Terrain-Cut commercial front mower; and

WHEREAS, as members of Sourcewell, the City of Cloverdale was able to secure a pre-negotiated government price quotation from a local vendor as one of the quotations; and

WHEREAS, the third vendor was a no-response to the bid solicitation; and

WHEREAS, Belkorp Ag LLC, of Stockton California, provided the City of Cloverdale a lowest quotation for a John Deere 1570 Terrain-Cut commercial front mower; and

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Cloverdale hereby awards a contract to Belkorp AG LLC, of Stockton California, for the purchase of one John Deere 1570 Terrain-Cut commercial front mower in the amount of THIRTY-EIGHT THOUSAND DOLLARS (\$38,000.00) and authorizes the City Manager to execute said purchase contract.


