**RESOLUTION NO. 056-2021**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE APPOINTING JOE PALLA TO FILL  
THE CITY COUNCIL VACANCY FOR THE REMAINDER OF THE TERM, ENDING DECEMBER 2022,  
RESULTING FROM THE RESIGNATION OF COUNCIL MEMBER JASON TURNER**

**WHEREAS**, on May 3, 2021, Council Member Jason Turner submitted a letter of resignation, effective May 3, 2021; and

**WHEREAS**, the term of the vacated position expires in December 2022; and,

**WHEREAS**, according to California Government Code § 36512(b), the Council must within 60 days (by July 2, 2021) either appoint an eligible person to fill the vacancy for the remainder of the term, or call a special election so the voters may elect a successor; and,

**WHEREAS**, to be a qualified individual to fill the vacancy, a potential appointee must be a registered voter, at least 18 years of age, and reside within the city limits of the City of Cloverdale; and

**WHEREAS**, on May 12, 2021, the City Council decided to appoint a qualified individual to fill the remainder of the term of the vacated position because the cost of a special election was estimated to be between \$16,000 and \$26,500, which would have been an unanticipated expense to the General Fund and urgency to fill the position; and

**WHEREAS**, the City Council solicited letters of interest from potential candidates and on the City Council regular meeting of June 9, 2021, held candidate interviews; and

**WHEREAS**, the City Council has determined that Joe Palla is a qualified individual to fill the vacancy, in that Joe Palla is a registered voter, at least 18 years of age and has been a resident resides in the City of Cloverdale.


**NOW THEREFORE BE IT RESOLVED**, by the City Council of the City of Cloverdale as follows:

1. The City of Cloverdale does hereby appoint Joe Palla to fill the City Council vacancy for the remainder of the term resulting from the vacancy of Council Member Jason Turner.
2. The City Clerk is hereby authorized and directed to administer the oath of office to the appointee and to carry out all actions necessary and appropriate to seat Joe Palla on the City Council and permit Joe Palla to take office as a City Council Member of the City of Cloverdale in accordance with applicable law.




